ARTICLES OF ORGANIZATION

in the State The undersigned, an attorney duly licensed to render professional services as such in the of Florida, hereby makes, subscribes, acknowledges and files these Articles of Organization to form a professional limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act and other laws of the State of Florida.

ARTICLE I NAME

The name of the professional limited liability company shall be Arthur G. Yeager, Chartered (the "Company").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of the Company is located at, and its mailing address is, 245-1 East Adams Street, Jacksonville, Florida 32202.

ARTICLE III BUSINESS, OBJECTS OR PURPOSES

The general nature of the business to be transacted by this Company, or the objects or purposes of the Company, shall be as follows:

- to engage in every aspect in the practice of law and all its fields of specializations as are usually engaged in by attorneys;
- to engage and render the professional services involved only through its officers, agents and employees who shall be attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Company;
- to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and to own real and personal property necessary for the rendering of the above-described professional services; and
- to do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Organization or any amendments thereof, and either alone or in

Each member must be duly licensed or otherwise legally authorized to practice law in the State of Florida. Pursuant to Section 608.4235, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have the authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VII TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

ARTICLE VIII MANAGER

The Company shall be managed by one or more managers and is, therefore, a managermanaged company. Each of the managers shall be of full age and shall be duly licensed or otherwise legally authorized to practice law in the State of Florida. The managers shall be elected in the manner set forth in the Operating Agreement. The managers shall hold the offices and have the responsibilities accorded to them by the members as set out in the Operating Agreement.
