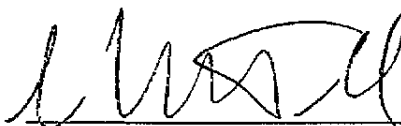
ARTICLE VI — Limitation on Agency Authority of Members

ARTICLE VII — Date of Existence

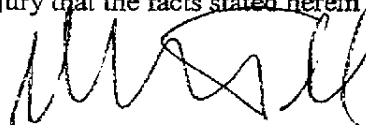
Pursuant to Section 608.409(1) of FLLCA, the existence of the Company shall commence effective as of March 23, 2006.

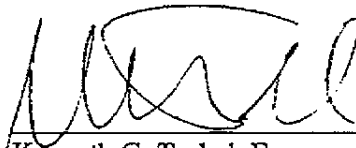
