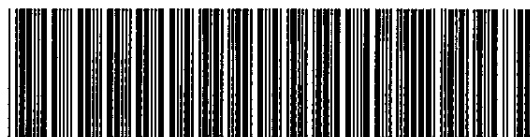

**ARTICLES OF ORGANIZATION
OF

The period of duration for the Limited Liability Company shall be perpetual.


ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS


