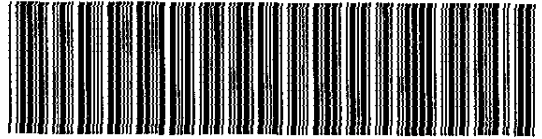

**ARTICLE I**  
**(Name and Principal Place of Business)**
