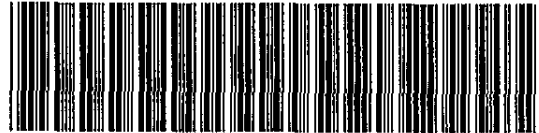

**ARTICLES OF ORGANIZATION

The period of duration for the Limited Liability Company shall be perpetual.


ARTICLE VI – ADMISSION OF ADDITIONAL MEMBERS


