The name of the limited liability company is: A & J Borrow Properties, LLC

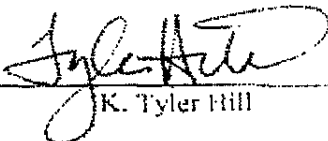
**ARTICLE II. ADDRESS**
