The undersigned, acting as the organizer of LAS VEGAS RV LOT, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is LAS VEGAS RV LOT, LLC.

ARTICLE II PURPOSE AND POWERS

- Purposes. The Company is organized for any legal and lawful purpose for which a A. limited liability company may be organized pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.
