**ARTICLES OF ORGANIZATION
FOR
LAS VEGAS RV LOT, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the organizer of LAS VEGAS RV LOT, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is LAS VEGAS RV LOT, LLC.

**ARTICLE II
PURPOSE AND POWERS**

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.

The Company shall admit new members as provided in the Operating Agreement of the Company.


**ARTICLE VII
