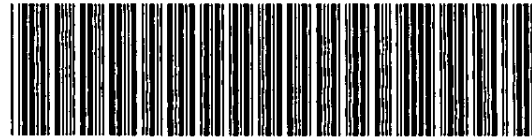



The name of the limited liability company is "Gulf Coastal Concepts, LLC," which is hereinafter referred to as the "Company."


