ARTICLES OF ORGANIZATION OF PINE RIVER VIEW, L.L.C.

ARTICLE I

The name of this Limited Liability Company shall be PINE RIVER VIEW, L.L.C., (the "Company").

ARTICLE II DURATION

> ARTICLE VII NEW MEMBERS
