**ARTICLES OF ORGANIZATION  
OF  
GROUP 154, LLC**

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I.     Name. The name of the Limited Liability Company is GROUP 154, LLC.


