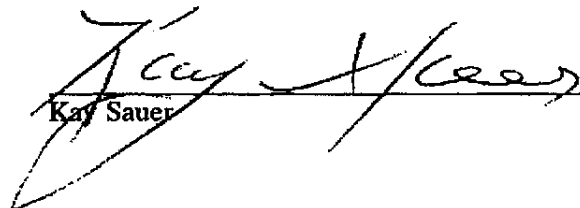
ARTICLE VI - TERMINATION OF EXISTENCE
