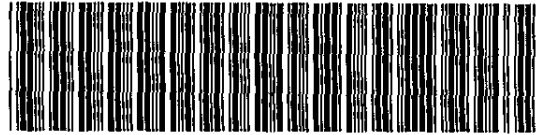

ARTICLE V. - AMENDMENTS TO ARTICLES


