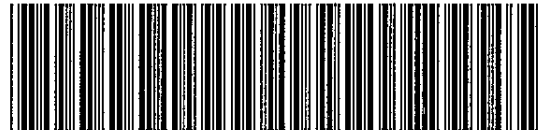

The name and the Florida street address of the registered agent is: Richard Pacanowski, 1330 MacTavandash Drive, Oviedo, Florida 32765.


