

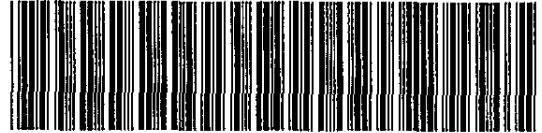

The name of the Limited Liability Company is 2000 OCEAN DRIVE, LLC (the "Company").


