ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

ARTICLE V -- CAPITAL CONTRIBUTIONS

The Regulations and the Operating Agreement, if any, shall determine the manner in which such the **Manager(s)** are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. 
