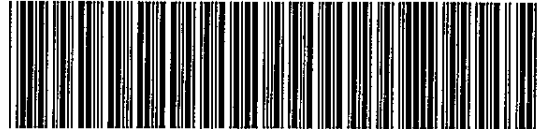



**ARTICLES OF ORGANIZATION OF
TAILORED MAID TO SERVE YOU, LLC**

Article I

The name of the limited liability company ("Company") is TAILORED MAID TO SERVE YOU, LLC.

Article II

The mailing and street address of the Company's principal office is 202 Addington Drive, DeLand, Florida 32724. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The name of the Company's initial registered agent in Florida is CONNIE D. JANSEN . The address of the Company's registered office in Florida is 202 Addington Dr., DeLand, Florida 32720. The mailing address is the same.

Article V

The Company is to be managed by the Members. The Initial Managing Members will serve until the first annual meeting of the Members. The Initial Managing Members are identified as follows:

Article VI

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


Article VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Regulations.


