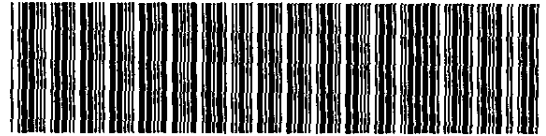



The Members may continue the business in accordance with the terms and subject to the conditions set forth in the Operating Agreement of the Limited Liability Company.




