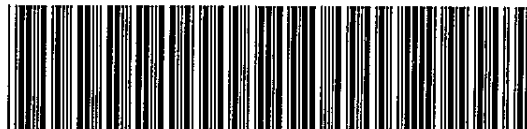

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, does hereby adopt the following Articles of Organization:

**ARTICLE I**  
**Name**

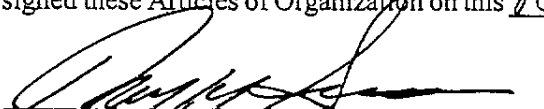
**ARTICLE VII**

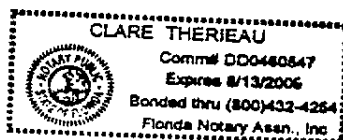

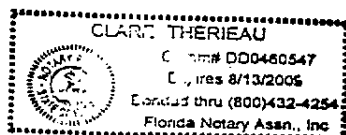


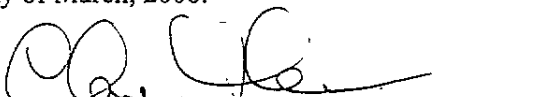
