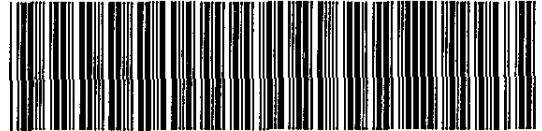

**ARTICLES OF ORGANIZATION
OF
CURLEW HILLS MEMORY GARDENS PET CEMETERY, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article 1 – Name

The name of this limited liability company is CURLEW HILLS MEMORY GARDENS PET CEMETERY, LLC ("Company").

Article 2 – Duration

The Company shall have perpetual duration.

Article 3 – Mailing Address and Street Address

The Company's principal office mailing address is P.O. Box 1950, Palm Harbor, Florida 34682-1950. The Company's principal office street address is 1750 Curlew Road, Palm Harbor, Florida 34683.

Article 4 – Registered Agent and Office

Article 5 – Members

Members of the Company shall be admitted as Company members, but only pursuant to the Company's Operating Agreement.

Article 6 – Management of the Company

No oral agreement among any of the Company's members or managers will be deemed or construed to constitute any portion of, or

The existence of the Company shall commence on the date of filing the Articles of Organization with the Florida Department of State.


