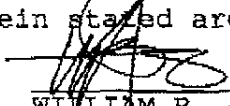

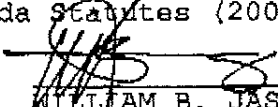
ARTICLES OF ORGANIZATION OF
