Dear Brenda,

This letter is to serve as reinstatement of our limited liability company name PAK LLC. We received a letter dated 10/6/2008, from the Florida Department of State Division of Corporations stating that the name PAKLLC was no longer available and to file an amendment changing the name of our LLC. A \$277.50 reinstate fee as well as a \$25 amendment fee was required.

A phone call to address the contents of the letter was made to the above Department's Administrative Specialist III, Brenda. We formed the LLC in April, 2006. A limited liability annual report/uniform business report was due between January 1 and May 1 of 2007. We failed to file the report. Per Brenda a courtesy letter was sent as a reminder but we never received it as it was sent to the company address not the mailing address which are not the same. On 4/10/2006 we amended the company address change which at that time was the same as the mailing address. Per Brenda since we did not specify that the mailing address was to stay the same they assumed that the new company address was also to be the mailing address. She stated that it was an oversight on their part. Therefore we did not receive the second notice either regarding our requirement to file an annual report in 2008.

Per Brenda the reason the name is no longer available it was given to another corporation in January 2007, in error, since we had until May 2007, to file our annual report. We would have filed if we had received the reminder letter and that corporation would have had to give up that name. So now since two years have lapsed we are unable to have their name removed.

We are aware that there is another business with the name PAK. We are asking the state to reinstate our name PAKLLC.
