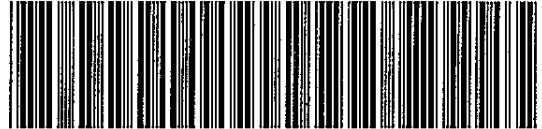

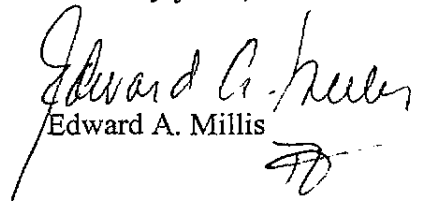

The company shall have perpetual existence.

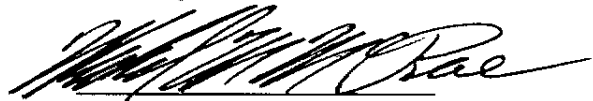

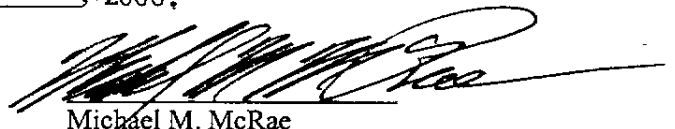
