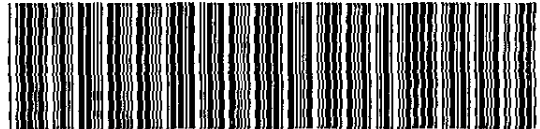

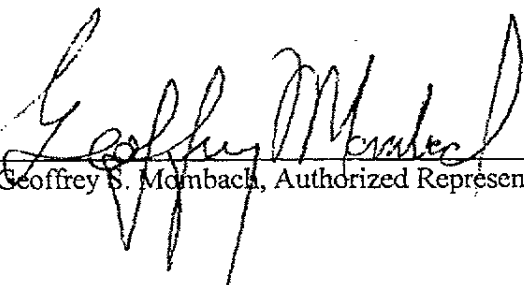
FIRST: The Articles of Organization were filed on April 5, 2006 and assigned document number L06000035333.
