**ARTICLES OF ORGANIZATION  
OF  
DIVERSIFIED SERVICES OF FLORIDA, LLC**

The undersigned Organizers of a limited liability company organized under the Florida Limited Liability Company Act do hereby adopt the following Articles of Organization for such limited liability company.

**ARTICLE I  
NAME OF THE LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be Diversified Services of Florida, LLC.

**ARTICLE II  
ADDRESS**

**ARTICLE III

PERIOD OF BURATION**

**ARTICLE V

The actions of a member, manager, or any other person acting in any capacity other than as a manager of the limited liability company in accordance with the terms of its operating agreement shall not bind the limited liability company.

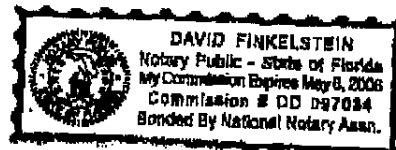
