EXHIBIT "A"

- 1. the entry of a decree of judicial dissolution pursuant to the Florida Limited Liability Company Act;
- 2. the vote of the manager and the members;
- 3. the sale of all or substantially all of the assets of the Limited Liability Company or any similar transaction with aimilar effect (unless a Majority in Interest of the members elect to continue the business of the Limited Liability Company, in which event the Limited Liability Company will continue);
- 4. the happening of any other event that makes it unlawful to carry on the business of the Limited Liability Company; or
- 5. dissolution pursuant to Article VII and the Operating Agreement of the Limited Liability Company; or
- 6. the failure by the Limited Liability Company to commence operations of its business by the 12-month execution of the Operating Agreement of the Limited Liability Company (which date shall be automatically extended by periods of time equal to the duration of any force majeure events).
