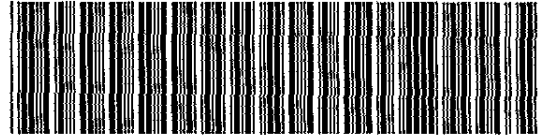

ARTICLE III – DURATION




