

## ARTICLES OF ORGANIZATION

### SUMMERLIN SOUTH LAND, LLC

#### A LIMITED LIABILITY COMPANY

- 1. Name. The name of the limited liability company is: Summerlin South Land, LLC.
- 2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

- 4. **Term.** Term of this LLC shall be perpetual.
