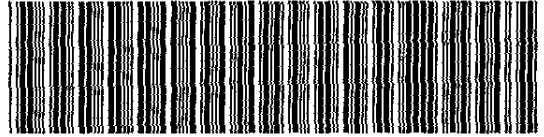

ARTICLES OF ORGANIZATION
KNICELEY & ASSOCIATES REALTY GROUP, LLC

1. **Name.** The name of the limited liability company is KNICELEY & ASSOCIATES REALTY GROUP, LLC.

7. **Management.** Management of the Limited Liability Company at the time of formation shall be by manager(s) whose name(s) and address(es) are as follows:




