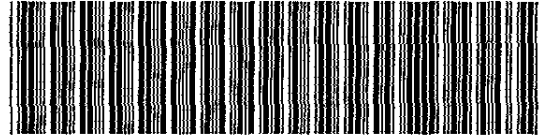



**ARTICLES OF ORGANIZATION OF
SN HAULING, L.L.C.**

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") **SN HAULING L.L.C.**

ARTICLE II. PURPOSE
