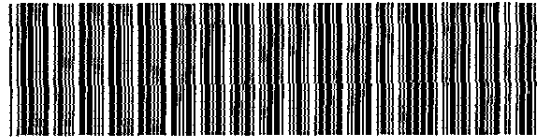


TAG – S, LLC
