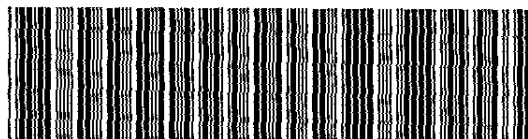


1. Name. The name of the Company is MC-1904, LLC.


