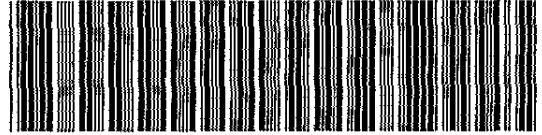


1. Name. The name of the Company is MC-603, LLC.


