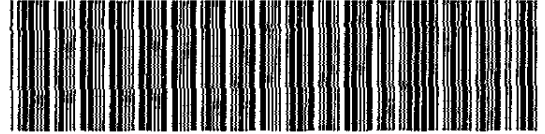


1. Name. The name of the Company is MC-602, LLC.


