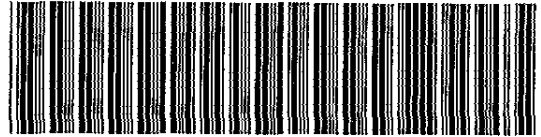


MC-1703, LLC


