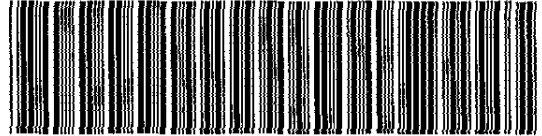

## ARTICLES OF ORGANIZATION

OF

#### ARTICLE I -- NAME

The name of the limited liability company shall be CORTEZ INVESTMENTS, LLC ("Company").
