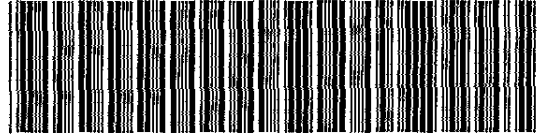


1. Name. The name of the Company is MC-2107, LLC.


