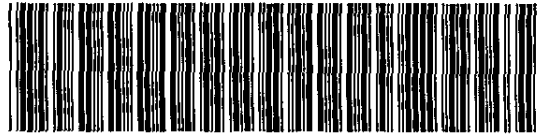

Management


The Company will be a manager-managed company. The initial Manager shall be Tomas Pequeno, Jr.
