THE TITLE TEAM, L.C., a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization, in accordance with the requirements of Chapter 608, Florida Statutes, hereby certifies as follows:

1. The Articles of Organization of the Company were filed by the Department of State of the State of Florida on April 6, 2006, and assigned document number L06000036341.
2. The Amendment to the existing Articles of Organization being effected hereby is that resulting from completely deleting Article I of the Articles of Organization as of the date hereof, and by substituting in its place the Article set forth below.
3. As amended below, Article I of the Articles of Organization has the sole effect of changing the Company's name from "The Title Team, L.C." to "Insured Title Agency, L.L.C." The Amendment to the existing Articles of Organization being effected hereby will make no change in the current capital structure of the Company.
4. This Amendment to the Articles of Organization was approved by a Written Consent of the Sole Member of the Company, adopted on February 21, 2007.
5. The Amended Articles of Organization shall be effective immediately upon filing by the Department of State of the State of Florida, all required taxes and fees having been paid, and thereafter the name of the Company shall be "Insured Title Agency, L.L.C." and Article I of the Articles of Organization of the Company shall read as follows:


