ARTICLES OF ORGANIZATION OF JOHN C. PETERSON, LLC

The undersigned Organizer of a limited liability company organized under the Florida Limited Liability Company Act does hereby adopt the following Articles of Organization for such limited liability company.

ARTICLE I NAME OF THE LIMITED LIABILITY COMPANY

The name of the limited liability company shall be John C. Peterson, LLC.

ARTICLE II ADDRESS

The actions of a member, manager, or any other person acting in any capacity other than as a manager of the limited liability company in accordance with the terms of its operating agreement shall not bind the limited liability company.
