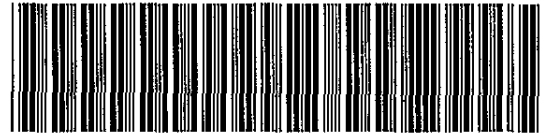

## ARTICLE VII — Indemnification


The Limited Liability Company shall indemnify its members, managers and agents to the fullest extent permitted by law.
