ARTICLES OF ORGANIZATION QE PARTNERS, LLC

THOURS THE SOUTH OF THE SOUTH O The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

<u>ARTICLE I</u>

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is QE Partners, LLC (the "Company"). The Company's principal address and mailing address is 511 S. Westland Avenue, #16, Tampa, FL 33606.
