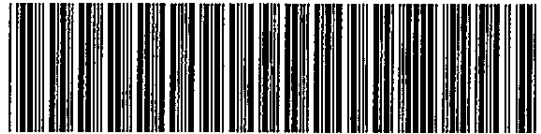

**ARTICLES OF ORGANIZATION
OF

Management of the Company


The Company shall be managed by Betty C. Gorsage (Mgr), 215 Pensacola Road, Belleair, Florida 33756.


