#### ARTICLES OF ORGANIZATION

OF

#### RAYMOND, PAT & RON, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be RAYMOND, PAT & RON, LLC ("company").

#### **ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 715 South Collins Street, Plant City, Florida 33563.

#### ARTICLE III -- DURATION
