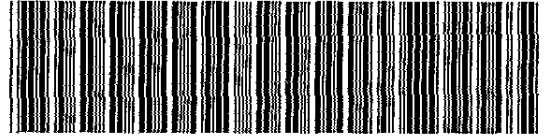

ARTICLES OF ORGANIZATION

OF

1. Name. The name of this limited liability company is Nelson's Walk, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State
