ARTICLES OF ORGANIZATION OF R & C PROPERTY GROUP 2, LLC

The undersigned, for the purpose of forming a limited liability company under the Plorida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be R & C PROPERTY GROUP 2, LLC
