ARTICLES OF ORGANIZATION OF RB PROPERTIES OF FLORIDA, LLC, a Florida Limited Liability Company



The undersigned, being the initial member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME
