**ARTICLES OF ORGANIZATION OF  
CLEARFORM EAST, L.L.C.**

**ARTICLE I - NAME**

The name of this Limited Liability Company shall be CLEARFORM EAST, L.L.C.

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company shall be 3011 Manatee Avenue West, Bradenton, Florida 34205.

**ARTICLE III - DURATION**
