ARTICLE V - MANAGEMENT



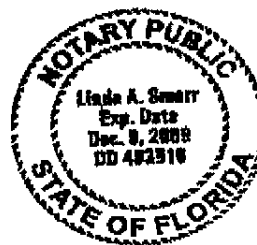
