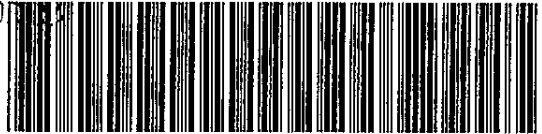

**ARTICLES OF ORGANIZATION OF
JF SOUTH-306, LLC**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be **JF SOUTH-306, LLC**.

SECOND: **JF SOUTH-306, LLC** shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of **JF SOUTH-306, LLC** may be obtained from the Manager at 322 South 6th Avenue, Wauchula, Florida, 33873, which is the place in the State of Florida where the principal office of the limited liability company is located. 


